INVITED THINKERS AND PROVOCATEURS

At the core of the conference are the ideas of creative thinkers who were commissioned to write essays in advance. As a whole, the essays follow the metaphor of "journey" — they will look at where the arts field has been, challenges it faces today, and profound changes that lie ahead. Don't Miss Breakfast!

Note that breakfast is provided daily at your hotel or inn from 7:30 – 9:00. Conference sessions begin at 9:30 am at the convention center and other locations in the Taos historic district. (See the map on the back cover.)

On Tuesday morning, a light continental breakfast is provided at the convention center during roundtables from 8:00 to 9:00 am.

Because space is limited on Pueblo Tours and in a few sessions, tickets are provided as a way to prevent overcrowding. These sessions are noted in the schedule. Four Short Plays: Four Big Ideas

Tuesday, October 23 8:30 PM

After dining together at the convention center Tuesday evening, we will cross the street to the Taos Community Theater for a special performance of Four Short Plays: Four Big Ideas, a work commissioned by GIA for plenary sessions at the Council on Foundations Annual Conference in May 2007.

Theater artist KJ Sanchez and ensemble members are offering storytelling workshops for conference participants during all breakout sessions. Stories from these sessions will be combined with excerpts from the original script for an evening of theater, featuring members of the original cast along with grantmaker performers and a program officer choir!

Conference Meals: Sustainable Culture

Conference plenary luncheons in Taos are designed to reflect the diverse human cultures of New Mexico as well as incorporate the products of sustainable agriculture, organic farming, micro-enterprise, and the "slow food" movement. We've worked to create conference meals from products raised and harvested within 100 miles of Taos to the degree possible. In addition, meals include ingredients, recipes, and cultural practices from the overlapping cultural traditions of the region. Conference participants also have the opportunity – and responsibility – to participate in some hands-on aspects of meals, grinding corn for tortillas, for example, or assisting in roasting chiles. We will hear from some of the local farmers, ranchers, producers, and culture-bearers whose products and traditions make up these meals - not only their stories, but their poetry, music, and spiritual practices.

A Taste of Taos – Fresh Out of the Horno Oven

GIA commissioned adobe specialist, Steve Truillo, to build an horno oven at the Taos Convention Center just for this conference. Hornos are a tradition shared by Native, Spanish and Anglo cooks and bakers. The new horno will be in use night and day during the conference, providing a rare chance for participants to taste baked items from the cultures of New Mexico. Taos Pueblo tribal member, Celestina Concha, will create traditional bread in the horno for all to enjoy at meals and to sample throughout each day. The horno will remain after we leave, a permanent gift to our host city.

Taos Pueblo Tours - Visit a North American Treasure

By arrangement with the Taos Pueblo tribal government, tours of the Pueblo are offered seven times during the conference as one option during break-out sessions. Continuously inhabited for more than 1,000 years, Taos Pueblo is designated as both a National Historic Landmark and a World Heritage Site by UNESCO. Tribal members will lead the tours, featuring time to meet with Pueblo artists. Because space on each tour is limited, tickets for each day's tour are available each morning at the conference registration desk. When the tickets for a specific tour are gone, you will know that tour is at capacity.

Focus Groups - Help Envision GIA's Future

Come help develop a new framework for GIA's future. In sessions hosted by GIA executive committee members and facilitated by consultant Paul Harder you will get a snapshot of GIA today and you will be asked to contribute to a vision for its future. GLOSSARY: SESSION FORMATS & ROLES

Formats for exchange in this conference have been rethought in a desire to make this, as much as possible, a safe place to discuss, argue, try out ideas, and learn from each other. The standard "panel presentation," for instance, is not the main vehicle for sharing information; instead the most common format here is the "working session," where participants can think and talk together, candidly and, we hope, productively. In the same spirit, instead of "panelist," we dug into the dictionary and found "interlocutor" — "a person who takes part in a conversation." Below you'll see how we adapted the term to our ends.

The glossary here provides short descriptions of the formats and roles that appear throughout the conference schedule that follows.

FORMATS

Working Session

Opportunity for a group of conference participants to roll up their sleeves and get some work done. Led by a moderator. Includes identified interlocutors.

Dialogue

Interview or conversation between two people, followed by open discussion with the whole group. Sometimes includes invited interlocutors.

Roundtable

Informal discussion – or "free-for-all" – around a named topic. Kicked off and facilitated by a moderator. Not only at breakfast.

Briefing

Presentation by one person: recent report, news, significant event, special field of expertise, etc. Always allows for discussion. Sometimes includes invited inerlocutors. Presenter leads the session.

Rapid Report

Chance to hear or make short (5-minute) reports about a specific idea, a recent report or study, or new project. Good for networking and finding new colleagues. Sign up sheets are available in the Resource Room

ROLES

Moderator

Facilitates a working session, roundtable discussion, "rapid reports" session, etc. Always encourages discussion.

Interlocutor

[in-ter-lok-yuh-ter] Participates actively in a conversation. Is willing to be the first to respond, but is not expected to present prepared remarks. Brings something of value to a session: relevant experience, special expertise, valuable perspective, a shared or similar challenge.

Presenter

Presents material for a one-person briefing or a "rapid report." Almost always without technological aid. Not in a 4 or 5 person, "talking-head" format.

Correspondent

Attends and writes a short report on a session. Reports may appear in a future *Reader*, on GIA's web site, or as notes to participants. More correspondents are welcome. If you find something provocative or useful that you would like to write about, sign up in the Resource Room.
